A California Energy Commission Committee is reviewing an Application for Certification (AFC) by Starwood Power-Midway, LLC, to construct and operate a 120 megawatt simple-cycle (peaking) power plant, the Starwood-Midway Energy Project, in an unincorporated area of western Fresno County.

The Committee will conduct a Prehearing Conference and, **if no issues are contested**, immediately conduct an Evidentiary Hearing covering all potential impacts of the proposed power plant. **The public and interested agencies are encouraged to attend and make comments on the topics to be discussed listed in the side bar.** Written comments on the proposed project may be submitted to the Energy Commission, Docket Unit, MS-15, 1516 - 9th Street, Sacramento, CA 95814 at any time prior to the close of the proceeding. Reference Docket No. 06-AFC-10.

Documents: The Staff of the Energy Commission has published an independent analysis evaluating potential project impacts, mitigation, and proposed Conditions of Certification. **Prehearing Conference
– Purpose &
Procedures:**

The Committee will conduct a Prehearing Conference to assess the parties' readiness for evidentiary hearings, to identify areas of agreement and dispute, and discuss procedures for the evidentiary hearing. To present evidence that will become part of the record upon which the Proposed Decision is based, a person group or agency must become an intervenor, also known as a "party" to the proceeding. (See below) **All Petitions to Intervene must be submitted no later than the date of the Prehearing Conference.**

During the Prehearing Conference, the Hearing Officer will review the topics (See Appendix A) with the parties including, among other things, an indication of whether any party requests an opportunity to present evidence or cross-examine a witness on any topic and the nature of the expected testimony.

**Prehearing Conference
Statements:**

Any party intending to present a witness at the evidentiary hearing shall file and serve a statement identifying the issue to be presented and the name of the witness(es) on or before October 26, 2007. The statement shall include a description of any potential legal issue and a description of any factual evidence potentially in dispute and the nature of the party's intended testimony.

**Becoming an
"Intervenor:"**

Anyone with a legitimate interest relevant to the siting of the proposed power plant may file a Petition to Intervene and become a formal party to this proceeding. Party status provides the rights to present independent evidence, receive pertinent documents, and cross-examine witnesses; it also imposes the duty to comply with various orders, procedures, and filing requirements, as well as be subject to cross-examination by other parties.

Intervention deadline:

In this proceeding, a Petition to Intervene shall be filed **no later than the date of the Prehearing Conference.** The Energy Commission, through its Public Adviser's Office, will assist anyone interested in preparing a Petition to Intervene. **"Combined"
Evidentiary Hearing:**

In the event no party contests any issue at the Prehearing Conference, the Committee will conduct a brief Evidentiary Hearing at the conclusion of the Prehearing Conference to establish the record upon which this case will be decided, which will include any documentation filed with the Commission's Docket Unit and served upon all parties on or before October 19, 2007, and identified by the Applicant in its Prehearing Conference Statement and the Energy Commission Staff's Final Staff Assessment. Witnesses may appear by declaration instead of in person since the topic is uncontested.

In the event a party contests an issue at the Prehearing Conference, the Committee will conduct a separate Evidentiary Hearing at a later date.
