REQUEST FOR AGENCY PARTICIPATION IN THE REVIEW OF THE CARLSBAD ENERGY CENTER PROJECT, APPLICATION FOR CERTIFICATION (07-AFC-6) – SUPPLEMENTAL INFORMATION

On August 1, 2008, the California Energy Commission received a Supplement to the Carlsbad Energy Center Project (CECP), Application for Certification (AFC). The Supplement describes several changes to the proposed project, including switching the facility's water source (from Title 22 reclaimed water from the Encina Waste Water Authority) by constructing a new on-site desalination system, separate and apart from the Poseidon Facility that will be built adjacent to the CECP. The AFC and the AFC Supplement are available for public review through a number of means detailed below.

Background

On September 14, 2007, Carlsbad Energy Center, LLC, (applicant) submitted an AFC to the Energy Commission to develop a thermal power plant at the existing Encina Power Station in the city of Carlsbad, California. The proposed project, a nominal 540 MW combined-cycle generating facility would be built at the existing Encina Power Station (EPS) on 23-acres where three unused fuel oil tanks currently reside. This tank farm would be demolished and removed, and the soil upon which the tanks currently reside would be remediated, as appropriate. The EPS has been in operation and periodically expanded since the early 1950s. The CECP would connect to the adjacent existing San Diego Gas & Electric (SDG&E) Encina 138-kilovolt (kV) Substation and to a proposed new SDG&E Encina East 230-kV Substation via an onsite transmission interconnection comprised of an overhead line and underground cable to the proposed new 230-kV substation. Natural gas would be provided through a new 1,100 foot-long interconnection to an existing Southern California Gas Company high pressure natural gas line located adjacent to the CECP site.

Energy Commission's Facility Certification Process

The CECP is under the Energy Commission's jurisdiction. The Energy Commission is responsible for reviewing and ultimately approving or denying all applications to construct and operate thermal electric power plants, 50 MW and greater, in California. The Energy Commission's facility certification process carefully examines public health and safety, environmental impacts, and engineering aspects of proposed power plants and all related facilities, such as electric transmission lines and natural gas and water pipelines. The Energy Commission is the lead agency under the California Environmental Quality Act (CEQA), but it produces several environmental and decision documents rather than an Environmental Impact Report.

Energy Commission staff is currently preparing a Preliminary Staff Assessment (PSA) on the proposed project, which we anticipate publishing in early September. After a public comment period and public workshop on the PSA, staff will release its Final Staff Assessment (FSA), which will serve as testimony in evidentiary hearings. A committee of two Commissioners will conduct hearings based on this testimony and then prepare a proposed decision for review and comment and then final consideration by the entire five-member Energy Commission. The Energy Commission will issue notices for these workshops, hearings and all public meetings at least 10 days prior to the event.

Agency Participation

Your agency's participation in the proceeding has been welcomed and appreciated. While not every agency has chosen to submit comments on this particular project, we especially encourage agencies concerned with water and soil resources, biological resources, waste management, and transmission system engineering to review the enclosed copy of the AFC Supplement (CD). We would appreciate receiving your comments on the Supplement by August 28, 2008.
