Subject: ORANGE GROVE POWER PLANT PROJECT (07-SPPE-2) STATUS REPORT 2

Pursuant to the Committee Scheduling Order dated September 28, 2007, the following is staff's Status Report 2 for the proposed Orange Grove Power Plant Project.

Current Issues and Activities for Resolution

Staff has been working through the discovery and analysis phases of the Small Power Plant Exemption process for the proposed project. The applicant recently indicated a new source of cooling water for the project which would be used instead of the previously proposed groundwater. A water contract is in the process of being ratified by the Fallbrook Utility District and J Power. The applicant has indicated the water will be supplied locally and will be tertiary treated municipal wastewater.

Schedule

The schedule has been affected due to the need for an application supplement on the new water supply for the project and a local emergency delaying staff's data response workshop scheduled for October 24, 2007. The workshop was cancelled because staff did not support a workshop until the applicant provided specific information on the new source of cooling water and the town of Fallbrook was under a wildfire-related evacuation order. A second round of data requests in the technical areas of air quality and biological resources is being prepared and is scheduled to be mailed to the applicant by early next week. The applicant will be responding to the data requests in a supplement to the application document.

A new date for the data response workshop will be determined after staff has had an opportunity to review of the supplemental information document and issue data responses.
