Dear Bureau of Land Management "BLM" representatives:

Please accept this letter as notice of our intention as the landowner of the above-referenced property to preserve my rights to access for future development of this land.

Our primary concern is access to our property using an approved BLM access road. The issuance of a dedicated public access easement "ROW" for Solar Millennium's proposed solar farm will eliminate the current access roads to Parcel #'s 341-110-07, 341-110-08, and 341-110-09, these current access roads are protected accesses under RS2477 which are protected under Federal and State Laws.

As property owners, the revocation of these accesses without an approved dedicated alternative route is unacceptable. Any other Kern County, State of California, development would be required to provide dedicated public access easements to allow for adjacent public access and certainly would not be allowed to land-lock adjacent private property land owners.

Pursuant to recent meetings with Mark Bullock adjacent landowner, we appreciate the BLM's tentative support of a dedicated public access easement 60' wide for a dedicated public access easement and access road to the South along the Eastern Section Line of Section 25 from Brown Rd. to the Northeast corner of Section 36 which is an aliquot section line and the nearest access to our property (approx. 250 ft.). This ROW will provide the greatest ease of access will simplify the preparation of a legal description and will ensure the preservation of our rights as private property owners for access and future development of this land.

In addition, we would like to have our existing ROW application amended to be approved under the conditions detailed in this written request. It is also preferable and requested that the ROW be provided in conjunction with the approval of the Solar Farm ROW and to have the ROW SEQA requirements for the ROW to Section 36 be waived due to the ongoing extensive SEQA-NEPA, Arch & Bio studies being performed under
