COMMISSION ORDER WITHDRAWING APPLICANT'S MOTION REGARDING JURISDICTIONAL WAIVER AND SCHEDULING ORDER

On July 25, 2011, the Committee in this proceeding convened a hearing, including oral arguments and public comments, on the Applicant's Motion for Order Affirming Application of Jurisdictional Waiver. By its motion, Applicant Solar Trust of America Development LLC (formerly Solar Millennium, LLC) ("STA") seeks an answer to a threshold question as to whether STA could redesign its proposed Ridgecrest Solar Power Project ("Project") utilizing only photovoltaic technology and continue to avail itself of the Energy Commission's exclusive jurisdiction over power plant certifications. arguing that it can waive its exclusion from the Energy Commission's jurisdiction under Public Resources Code, section 25502.3.

On July 28, 2011, the Committee issued an order after hearing requesting that the Commission consider acting on its authority under Title 20 of the California Code of Regulations, section 1204(c) and withdraw the hearing and resolution of STA's motion.

On August 24, 2011, the Commission considered the Committee's request. The Commission has not previously addressed the applicability of Section 25502.3 to photovoltaic power plants. In light of the precedential nature of the question presented in STA's motion, and the potential interest in the question on the part of stakeholders beyond the parties to this proceeding, the Commission hereby exercises its authority under Section 1204(c) to withdraw the above-referenced motion for consideration by the full Commission. The Commission clarifies that that all other proceedings in this AFC shall remain with the Committee.

The Commission acknowledges and takes into consideration the written briefs and letters regarding the motion filed with the Commission and submitted to the Docket Unit by certain parties and other interested entities to date, as well as the entire transcript of the July 25th hearing before the Committee. The Commission will provide all parties, any interested entities, and members of the public, one additional opportunity to file further briefing on the motion, however, such further briefing shall not be duplicative of legal or policy arguments already submitted by the same party, entity or person in this proceeding.

In addition, the Commission hereby directs the Chief Counsel to append to this order no later than August 26, 2011 a list of specific questions relevant to the motion which the parties to this matter shall address.

All briefs from parties and interested entities must be filed with the Commission, and submitted to the Docket Unit, and served upon the Proof of Service list plus the Chief Counsel no later than September 16, 2011 at 5:00 p.m.

The Commission will set a hearing on the motion by further order.

The Public Adviser is directed to transmit this order and the appended questions from the Chief Counsel via the Energy Commission listserv to ensure broad dissemination among interested stakeholders.

It is so ORDERED.
