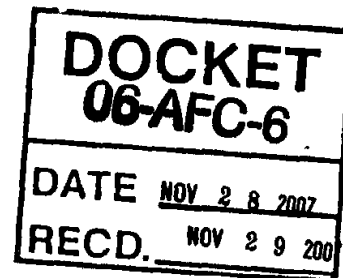

We have reviewed the witness availability list from Commission Staff. As we expressed in the Prehearing Conference, our preference would be to start with Traffic and Transportation and Land Use on 12/17. Our primary concern is getting through Traffic and Transportation and Land Use in one day, and by placing those subjects on the 18th, we do not have the ability to go into the next day. If 12/18 is the only day Commission Staff's witnesses are available for these topic areas, we request that all other party issues such as socioeconomics be placed on the 17th. We request that noise remain on the 18th as our witness on noise is only available on 12/18. We also think the logical presentation of evidence would be to put Traffic and Transportation before Land Use on the agenda regardless of the day the testimony is received.



We also repeat our request that in the interest of conserving hearing time, all direct testimony be limited to prefilled written direct.
