There will be a large volume of hazardous ammonia stored at this site and transported to and from this site via our busy streets.

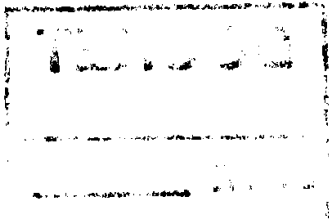


