Today I received the below communication from you directed solely to me. Whether the other parties of record have received this is unknown. In this regard, this is to request that all parties be included on all communications from your office.

Without addressing the final Exhibit List attached to your email, this is to also request clarification on the amount of time which the other parties have to review and agree with the distance calculations. Based on Ms. Graves email included below, she states that we would be provided that information yesterday. To date we have received nothing, although we have no objection to all parties receiving additional time to attempt to come to an agreement and appreciate the efforts of the City, CEC staff and applicant to take the lead on this issue.

In this regard, this is to request that all parties have at least three business days from the date of service of the proposed stipulation to have an adequate opportunity to examine the determinations arrived at by the applicant, City and CEC staff and to provide any input on any measurements on which these three may not be able to reach agreement.
