This letter is in response to your submittals of July and August 8-9, 2007, concerning Department of the Army (Corps) authorization to repower and develop an existing power plant. Activities associated with this action include: road grading, placing utilities above or under wetlands or tidelands, and/or the discharge of other fill material into waters of the U.S. The project area property is located at 1000 King Salmon Avenue, in the City of Eureka, Humboldt County, California.

Based on a review of the information in your submittal, the project qualifies for authorization under Department of the Army Nationwide Permit (NWP) 7 for Outfall Structures and Associated Intake Structures and NWP 12 for Utility Line Activities (72 Fed. Reg. 11,092, Mar. 12, 2007), pursuant to Section 404 of the Clean Water Act (33 U.S.C. Section 1344). See Enclosure 1. All work shall be completed in accordance with the following figures: "Figures 1, 2, 3, 4, 5, 5a, 5b, 6, 6a, 7, 7a, 8, 8a, and 8b (sheets 1-14)," all dated September 21, 2007

The project must be in compliance with the Terms and Conditions of the NWPs cited in Enclosure 1 and any Special Conditions specified in this letter for the NWP authorization to remain valid. Non-compliance with any Term or Condition could result in the revocation of the NWP authorization for your project, thereby requiring you to obtain an Individual Permit from the Corps of Engineers (Corps). Upon completion of the project and all associated mitigation and monitoring requirements, you shall sign and return the statement cited in Enclosure 2, certifying all work complies with the Terms and Conditions of the NWPs. Project authorization under the NWPs does not obviate any requirement to obtain other Federal, State, or local approvals necessitated by law.

Project authorization will remain valid for a period of two (2) years from the date of this letter, unless the NWPs are modified, suspended, or revoked. If the project has commenced or is under contract to commence construction prior to any modification, suspension, or revocation of the NWPs and the project could not comply with any newly issued NWP, you shall have twelve

(12) months from that expiration date to complete the project under the present Terms and Conditions of the NWP authorization.

Project authorization will not be effective until you have obtained Section 401 water quality certification from the Regional Water Quality Control Board (RWQCB), North Coast Region. If the RWQCB fails to act on a valid request for certification within two (2) months after receipt of a complete application, the Corps may presume a waiver of water quality certification has been obtained. You shall submit a copy of the certification to the Corps prior to the commencement of work.

To ensure compliance with this NWP authorization and to further minimize adverse impacts to water quality and aquatic resources, the project is subject to the following Special Conditions:

- 1) Stockpiles of fill will be isolated with silt fences and/or straw bales and placed in designated upland areas.
- 2) Equipment fueling and maintenance activities will be performed in a designated upland area, with containment and clean-up BMP's in place.
- 3) The project will be constructed during summer, dry season.
- 4) Following construction, disturbed areas will be mulched and/or seeded with a mix of fast growing native and sterile hybrid grasses.
- 5) Mitigation and monitoring will be implemented as specified in the "Buhne Point Wetlands Preserve Mitigation and Monitoring Plan," dated July 2007.
