Subject: PIO PICO ENERGY CENTER (11-AFC-1), STAFF'S PROPOSED REVISED SCHEDULE

Per the Committee's Scheduling Order dated May 24, 2011, staff is hereby notifying the Committee that certain developments are impacting the Committee's adopted schedule for this case and therefore staff is hereby requesting the Committee to adopt a revised project schedule.

On June 8, 2011, the applicant filed a Project Refinement document because they relocated a portion of the proposed, underground natural-gas line. Although the project refinement document is fairly thorough, it triggered the need to update several studies (e.g. traffic, cultural resources survey) which will take longer than the 30-days allotted for the outstanding data responses. Subsequently, on June 14, 2011 the applicant filed a request for an extension of time to respond to staff's data requests (and also objected to 6 data requests).

On June 21, 2011, staff filed its response agreeing to the applicant's request for an extension of time although it effectively extends the overall project schedule by the same amount of time (three weeks). As a result, staff is requesting the Committee to adopt staff's Revised Schedule, attached here.

It is worth noting that although staff is asking to extend the project schedule by 21-days, staff initially proposed (and the Committee adopted) an aggressive schedule that proposed publishing a Preliminary Staff Assessment (PSA) in 130-days rather than the standard 155-days under our 12-month process. The end result is that staff is on track to meet the schedule goals of our 12-month certification process. In that light, staff has made progress in coordinating with the applicant and the County of San Diego to have technical staff at the County assigned to assist Commission staff with ensuring LORS compliance and to quickly resolve any potential issues that may arise.
