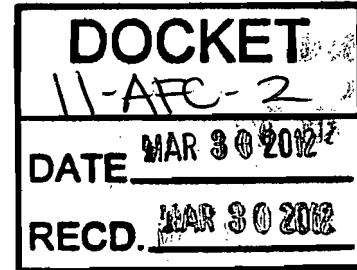

Pursuant to Section 2505(a)(4), Title 20 of the California Code of Regulations, Hidden Hills Solar I, LLC and Hidden Hills Solar II, LLC (collectively, the “Applicant”) hereby submits this “Repeated Application for Confidential Designation” for certain cultural resources information for the Hidden Hills Solar Electric Generating System submitted in response to Data Request 125 issued by California Energy Commission Staff.
