#### **Background**

At the February 26, 2013 Prehearing Conference, the Committee designated to conduct hearings in the above-captioned Application for Certification (AFC) proceedings **denied** the Motion for a Subpoena Duces Tecum brought by Intervenor, Old Spanish Trail Association, based upon the untimeliness of the filing. Next the Committee heard from each of the parties regarding their views as to which topic areas were not ready to proceed, the topics that were ready to proceed that require adjudication and those topics which would be amenable to resolution at Staff's March 5, 2013 workshop. The Committee ordered the parties to obtain and provide docket transaction numbers on any exhibits that had not yet been docketed by close of business Thursday, February 28, 2013. The Committee explained the informal hearing process that will be employed at the evidentiary hearing. A lengthy discussion ensued regarding the order in which to take evidence on the various topics at the upcoming Evidentiary Hearings. The parties then discussed the scheduling of opening and rebuttal briefs, which was followed by public comment.

#### **Topics Not Ready to Proceed**

At the Prehearing Conference, all parties indicated that all topics were ready to proceed except Staff, Intervenor MacDonald and Intervenor Center for Biological Diversity (CBD). However, in the course of discussions at the conference, Staff indicated that the topic of socioeconomics was a purely legal question which may be resolved at the March 5, 2013 workshop. This was the only topic that Staff had indicated was not ready to proceed and that all others topics were ready to proceed. CBD stated that they were ready to proceed on all issues. Intervenor MacDonald indicated that her characterization of topics as not ready to proceed was based upon the absence of information in the record and her inability to get satisfactory responses to her questions at workshops.

The Applicant has the burden of ensuring that the record contains substantial evidence on all topic areas. Applicant indicated that all topics are ready to proceed and assumes the risk of delays or even denial of the application if they have misjudged the completeness of the evidence. We are satisfied that all topics are ready to proceed.

#### **Disputed Topics**

According to Intervenor, Cindy R. MacDonald, all topics are in dispute and need adjudication at the hearing. The Committee will receive evidence in the form of written and live testimony addressing factual issues on the following topics at the Evidentiary Hearings from the parties as indicated in the parentheses:

- 1. ALTERNATIVES (Applicant, Staff, CBD, MacDonald)
- 2. CULTURAL RESOURCES (Applicant, Staff, MacDonald, OSTA, Arnold)
- 3. BIOLOGICAL RESOURCES (Applicant, Staff, CBD, MacDonald, Arnold, Inyo)
- 4. LAND USE (Applicant, Staff, CBD, MacDonald, Inyo)
- 5. SOCIOECONOMICS (Applicant, Staff, CBD, MacDonald, Inyo)
- 6. SOIL AND WATER (Applicant, Staff, CBD, MacDonald, Inyo, Arnold, Armargosa)
- 7. VISUAL RESOURCES (Applicant, Staff, OSTA, MacDonald, Inyo, Arnold)
- 8. WORKER SAFETY/ FIRE PROTECTION (Applicant, Staff, MacDonald, SIFPD)
- 9. TRAFFIC AND TRANSPORTATION (Applicant, Staff, MacDonald, Inyo)
- 10. NOISE (Applicant, Staff, MacDonald, Inyo)
- 11. GEOLOGY/PALEONTOLOGY (Applicant, Staff, MacDonald, Arnold)
- 12. PROJECT DESCRIPTION (Applicant, Staff, CBD, MacDonald)

Energy Commission staff indicated at the Prehearing Conference that the following topics would likely be resolved in the March 5, 2013 workshop prior to the Evidentiary Hearings:

- 1. AIR QUALITY (including GREENHOUSE GASES)
- 2. HAZARDOUS MATERIALS
- 3. TRANSMISSION LINE SAFETY AND NUISANCE
- 4. PUBLIC HEALTH
- 5. WASTE MANAGEMENT
- 6. FACILITY DESIGN (including GENERAL CONDITIONS)
- 7. POWER PLANT EFFICIENCY
- 8. POWER PLANT RELIABILITY
- 9. TRANSMISSION SYSTEM ENGINEERING

The Committee recommends that the parties take full advantage of this last workshop before the Evidentiary Hearings. If the parties are unable to come to resolution of these last nine topics, time will be allotted to allow the Applicant, Staff and Cindy MacDonald to question witnesses on these topics, but the Committee will limit the testimony to issues of fact only.

#### **Required Filings**

At the Prehearing Conference, all parties were ordered to obtain and provide docket transaction numbers (TN numbers) on any exhibits that had not yet been docketed by close of business Thursday, February 28, 2013.

At the Evidentiary Hearings, Applicant, Staff, and Intervenors shall be prepared to present evidence and testimony on the disputed topics as indicated in the lists above. Testimony shall be limited to those witnesses identified in the Prehearing Conference Statements (see attached Witness List). Applicant, Staff and Intervenors shall exchange copies of any documentary evidence not already provided, including, but not limited to, witness qualifications by close of business Thursday, February 28, 2013. Applicant, Staff and Intervenors shall exchange lists of any witnesses who will be testifying by telephone by noon, Thursday, March 7, 2013.

Opening Briefs will be due at noon on Friday, April 5, 2013 and Rebuttal Briefs will be due noon on Wednesday, April 24, 2013. Copies must be provided to those on the Proof of Service and mailing lists and may be filed electronically according to the Committee's August 14, 2012 Committee Order Regarding Electronic Document Formats, Filing and Service of Documents and Other Matters. The briefs shall be received by the other parties and the Commission's Docket Unit, 1516 Ninth Street, MS 4, Sacramento, California, 95814-5512, no later than 5:00 p.m. on the due date. Briefs must contain "HIDDEN HILLS SEGS, Docket No. 11-AFC-02" in the caption or heading. The parties shall also provide electronic copies of the above-referenced briefs to the Hearing Adviser via e-mail, in Microsoft Word format.

#### **Evidentiary Hearing Procedures**

The purpose of the Evidentiary Hearings is to establish the factual record necessary for a decision on the project proposal. The record is developed by the presentation of sworn testimony and documentary evidence. Testimony on undisputed topics shall be submitted by sworn declarations filed under penalty of perjury and offered into evidence by the parties.

The Applicant has the burden of presenting sufficient substantial evidence to support the findings and conclusions required for certification of the site and related facilities. (Cal. Code Regs., tit. 20, § 1748(e).)

The parties' witnesses who appear in person or telephonically shall be available for cross-examination at the Committee's discretion. Each party sponsoring a witness shall submit the qualifications of the witness into the record by declaration before moving the testimony and relevant documents into evidence. To save time, the Committee will not take time to describe the Exhibits that are moved into evidence since the evidence list will be made public prior to the hearings. All parties' opening and rebuttal testimony is deemed direct examination. No time will be allowed to discuss experts' resumés unless there is an objection to the witness as an expert.

Rather than taking time with the usual formal direct and cross examination of individual witnesses, the Committee will call all witnesses to testify as a panel on topics or issues within their expertise. The testimony may include discussion among the panel without the lawyers asking the questions. Instead, the Committee will ask the questions of the panel. If time permits, the Committee may allow questioning of the panel by the parties.

This informal hearing format would begin with Staff briefly summarizing the factual issues that are in dispute. The Applicant would then have an opportunity to comment or articulate their opinion and the basis of their position on the disputed factual issue. The panel, comprised of all parties' expert witnesses on the topic or subtopic, would be allowed to state their position on factual disagreements and the basis for their position. Dialogue between the panel members will be permitted to the extent that it is efficiently providing useful information to the Committee. The Committee may ask questions of any witnesses at any time. Parties may offer questions for the Committee to ask of any witness. The Committee may allow limited questions of the panel by the parties, at its discretion. The Committee will establish limits as needed on the number of questions a party may ask and/or the amount of time a party may consume asking questions.

If the informal process proves difficult or unproductive, the Committee may revert to formal examination at their discretion.

The Committee, in the interest of completing all topics areas at the Evidentiary Hearings efficiently, may curtail testimony or examination of a witness if it becomes cumulative, argumentative, or in any other way unproductive. The Committee intends to proceed according to the following schedule:
