Good Day Mr. Solorio

My name is Sonja Ramos. I live at 7819 Rancho Fanita Dr. Unit A Santee, CA. 92071. My family moved to this location in August of 1995. One of the main attractions was the beautiful views of Mission Trails Regional park. I remember standing in the empty upstairs master bedroom and saying to my husband "Look at that view. It is all regional park and it will never be touch. No one can ever develop it" I am shocked by the need to write to you today in hopes of protecting such a beautiful open space and the amazing views around us. The Quail Brush Power Plant Application before you now for approval feels like a terminal death sentence for a family member.

Current Zoning of this area is not compliant with the building of an industrial power plant. It is inconceivable to ask the City of San Diego to change the zoning of this land for any industrial purposes. The City of Santee is a small fish bowl and the topography unique. Air monitoring stations miles away from the projected plant location can not offer accurate information with regards to the air quality within the City of Santee.

I have spent years making healthy choices to improve my quality of life and eliminated the need for my asthma medication, If this application is approved, I will spending much of my time back in Doctors offices, giving my paycheck to pharmacies for needed breathing medication and treatments.

The opening of the eastbound 52 freeway has brought hundreds of commercial trucks to the City of Santee. These trucks only add pollution to our air. I opened communication with Minjie Mei code enforcement officer for the City Of Santee in December of 2011. My main focus being the City's Ordinance code 365. Ordinance 365 limits commercial truck use to local deliveries only. No thru trucks. Trucks are currently coming from and going to San Diego via Santee . The drivers blast down the Mission Gorge summit from the west and hit the intersection of West hills parkway at 55 miles an hour at 3,4,5,6,7 am and continue a steady flow thru the day 10 and 11 pm my walls shake like unstoppable all day earth quakes. Currently I am blasted awake at 3 or 4 am daily and unable to go back to sleep. The additional traffic due to the construction phase of this project is too unbearable to even think about. Our home sits right next to the proposed off site parking and shuttle location. Further gravely impacting our quality of life during the 19 month construction period. Please consider the existing traffic problems and conditions during your review and deny the Quail Brush Power Generation application.

Truthfully Mr. Solorio should this application be approved and all the LORS that currently block this type of project at this location be granted variances and exceptions allowing the construction of Quail Brush. My family will have no choice but to relocate. With little faith in conservation and consideration to override the destructive nature of this project. In the event this application is approved, I have initiated a 5 to 7 year exit California strategy for my entire family (myself, my husband, our 2 daughters, our son in law, and our grandson). How many hard working, employed, tax paying citizens can California afford to loose? Please deny this application and offer a "No Project Alternative." on the grounds of Visual impact, Air Quality, and Traffic Congestion.
