**RESOLUTION OF THE BOARD OF DIRECTORS OF THE MISSION VIEW HOME OWNERS ASSOCIATION SANTEE, CALIFORNIA, OPPOSING THE SITING OF THE QUAIL BRUSH GENCO LLC GENERATION PROJECT POWER PLANT**

**WHEREAS**, an Application for Certification (AFC) dated Aug 25, 2011 for the construction and maintenance of a nominal 100-megawatt (MW) intermediate/peaking load electrical generating facility ("Power Plant") was filed with the California Energy Commission (CEC), consisting of eleven (11) natural gas powered internal combustion engines each with a total displacement of 44,323 cubic inches, which includes erecting eleven (11) 100-feet in height X 4.0-feet in diameter exhaust smoke stacks, a 22-feet in height urea storage tank, a 20-feet in height used oil storage tank, a 20-feet in height new oil storage tank, an 18-feet in height radiator cooling tank, a 30-feet in height fire water storage tank, various other listed toxic chemical storage tanks, a 365-feet long X 70 feet wide X 32-feet in height engine generator housing building accompanied by a 92-feet long X 44-feet wide X 32-feet in height electrical housing building in the City of San Diego within one thousand one hundred (1,100) feet of the City of Santee border; and

**WHEREAS**, the power plant is proposed to be located within approximately 1.0 mile of all thirty one owner-residents' and Mission View Home Owner Association property with shared borders of Mission Trails Regional Park property and with a northwest facing direct unobstructed line of sight view of the proposed power plant project; and

**WHEREAS**, the construction of the described power plant project would unfairly and significantly de-value all Mission View properties causing irreversible and unmitigated damages to all 31 current owners investing well in excess of one half (+.50) million dollars each in Mission View property purchases between 2009-2010; and

**WHEREAS**, the proposed site would be located within approximately one thousand eight hundred (1,800) feet of the West Hills High School, nearby Chet F. Harritt and Carlton Oaks Elementary School, where all Mission View resident's children attend or will be attending; and

**WHEREAS**, the reduced air quality and the noise emitted from the power plant will have a direct detrimental, measurable and irreversible long term impact on all owner-residents, the City of Santee, and San Diego East County residents; and

**WHEREAS**, the proposed power plant location is at a major east-west commute artery that would cause unfathomable traffic delays for tens of thousands of daily commuters, and dramatically affect the majority of Mission View daily work commuters; and

**WHEREAS**, the proposed power plant location conflicts with the following land use documents:

1. The City of San Diego General Plan
2. The City of San Diego Municipal Code
3. The East Elliot Community Plan
4. The City of San Diego Multi-Species Conservation Program (MSCP)

and;

**WHEREAS**, the proposed industrial land use presents a serious and immitigable conflict of interest with MISSION TRAILS REGIONAL PARK, it's visitors, the nearby residences, the Little League Ball Fields and Local Parks, by permanently and/or irreversibly altering the quality in benefits and amenities offered by each to the City of Santee and the Greater San Diego County residents; and

**WHEREAS**, the Mission View Home Owner Association is in support of the RESOLUTION OF THE CITY OF SANTEE OPPOSING THE QUAIL BRUSH GENERATION PROJECT.

**IT IS HEREBY RESOLVED** that the MISSION VIEW Board of Directors formally and unanimously oppose the proposed location of the Quail Brush GENCO LLC Generation Project.

**BE IT IS FURTHER RESOLVED** that this Resolution shall be forwarded to the California Energy Commission and City of San Diego.


