#### BACKGROUND

CEQA requires that a cumulative analysis include "related past, present, and reasonably foreseeable probable future projects" (Guidelines §15355(b)). A lead agency must use "reasonable efforts to discover, disclose, and discuss" related projects, even if they are under review by another agency.

Agencies must make case-by-case determinations of whether possible future projects are truly "reasonably foreseeable." Because new projects are continually entering the environmental review process, lead agencies may set a reasonable cutoff date for which projects will be included.

HomeFed is the owner of property known as "Fanita Ranch" in the City of Santee near the proposed project site. Fanita Ranch has been approved for the development of a master-planned community, including, without limitation, approximately 1,400 residential units, commercial and recreational uses, as well as associated infrastructure and public amenities.

## **DATA REQUESTS**

- FR-1 For consideration of cumulative impacts in the area of Socioeconomics, please identify the amount and type of workforce needed by the Fanita Ranch project during construction and operation. Please include an estimated or actual construction start date and duration of construction, if available. Please identify the current status of the Fanita Ranch project.
- FR-2 For consideration of cumulative impacts in the area of Traffic & Transportation, please identify whether or not a traffic study has been initiated or completed for the Fanita Ranch project. If a traffic study is complete then please provide it. If the study is not complete then please provide the contact information for the project manager at the government agency with oversight of the CEQA review for the project.
- FR-3 For consideration of cumulative impacts in the area of Land Use, please list and provide a map showing all parcels (by parcel number and acreage) within the Fanita Ranch project that have been rezoned or are proposed to be rezoned from "open space" to another zoning designation. Also please list (by parcel number and acreage) and provide a map of all parcels within the Fanita Ranch project, if any, that have either proposed or completed a Boundary Line Adjustment to the City of Santee's subarea plan of the Multiple Species Conservation Plan (MSCP).
- FR-4 For consideration of cumulative impacts in the area of Biological Resources, please identify and provide a map of the total acreage of the proposed disturbance area of the entire Fanita Ranch project. Please also identify any environmental review (e.g. EIR, Neg. Dec., EA) that is underway. If an environmental document has been prepared and is available via the internet then please provide the URL.

- FR-5 Please provide any and all reports, studies and or other documents reasonably available to HomeFed which are related to the environmental analysis<sup>1</sup> of Fanita Ranch's potential impacts on the city of Santee's Fire Department. Also please provide any and all reports, studies and or other documents related to both the proposed and adopted mitigation measures to address such significant impacts.
- FR-6 Please provide any and all reports, studies and or other documents reasonably available to HomeFed which address any potential for mutual aid provided between the city of San Diego's Fire Department and the city of Santee's Fire Department.
