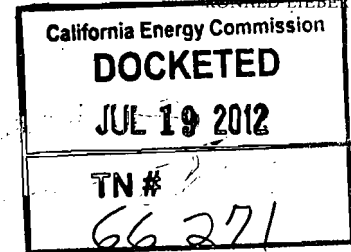

Pursuant to Section 2505(a)(4), Title 20 of the California Code of Regulations, Rio Mesa Solar I, LLC and Rio Mesa Solar II, LLC (collectively, the “Applicant”), hereby submits this “Repeated Application for Confidential Designation” for its Power Purchase Agreements assigned to the Rio Mesa Solar Electric Generating Facility.

On June 29, 2012, Energy Commission Staff motioned to compel the production of BrightSource Energy Inc.’s Power Purchase Agreements involving the Rio Mesa Solar Electric Generating Facility. Applicant hereby provides the full versions of the Power Purchase Agreements assigned to Rio Mesa Solar 1 and Rio Mesa Solar 2, with only highly sensitive, price-related information redacted. This confidential filing is contained on five CDs.

By letter dated March 29, 2012, the Executive Director approved the initial request for confidential designation regarding certain portions of the Power Purchase Agreement. The information submitted with this repeated application is substantially similar to the information submitted in the Applicant’s initial application, and all facts and circumstances relevant to the confidentiality of the information remain unchanged.
