Dear Mr. Luster

I am writing In response to your letter of August 3, 2012 to Felicia Miller at the California Energy Commission (CEC), regarding the Huntington Beach Energy Project (HBEP). Specifically, I am writing to respond to your comment that "...we recently initiated an investigation about possible LCP [Local Coastal Program] violations due to AES conducting grading and vegetation removal within areas of potential wetlands at the power plant site." You also noted that "...a site visit in July 2012 revealed that the site had been graded and vegetation removed [referring to alleged potential wetlands on the site.]"

AES has not, to my knowledge, directly, or through any of its subsidiaries, conducted any grading activities on the Huntington Beach Generating Station site. Since the late 1950's the previous owner of the Huntington Beach Generating Station, Southern California Edison, and AES have regularly conducted various site maintenance activities that include removal, pruning, or cutting vegetation. It may be that these routine maintenance activities have been confused with unauthorized vegetation removal in wetlands. There are also other entities acting on portions of the site no longer owned or controlled by AES. All activities by AES at the Huntington Beach Generating Station, including site maintenance, are conducted carefully in accordance with all applicable laws and regulations.

I also wish you to know that I am not aware of any Coastal Commission investigation regarding any activities on the Huntington Beach Generating Station site. I have not received any correspondence from you or your office regarding such a matter. I am confident that there is no need for such an investigation, but should you perceive the need to further pursue that course, please ensure I am informed and made aware of such action. I encourage you to communicate with more specificity regarding any concerns you or the Coastal Commission have regarding operations at the AES Huntington Beach Generating Station.

Communications regarding the proposed Huntington Beach Energy Project should be directed to the CEC in accordance with its service and notice lists for the Huntington Beach Energy Project proceeding.

The AES Corporation, through several different subsidiaries, including AES Huntington Beach, LLC, is committed to the safe and environmentally responsible production of clean and reliable energy for California.
