#### **AVENAL POWER CENTER, LLC'S STATUS REPORT #3**

Avenal Power Center, LLC ("Avenal Power" or "Applicant") submits this Status Report #3 to update the Committee on the status of the above referenced proceeding. Avenal Power is working to respond to California Unions for Reliable Energy's ("CURE") fifty-nine data requests submitted to Avenal Power Center, LLC on October 1, 2008. Avenal Power submitted objections to a number of CURE's data requests on October 20, 2008. Nonetheless, Avenal Power will provide responses to the extent the requested information is relevant and reasonable by October 31, 2008.

Avenal Power submitted Responses to CEC staff's Data Requests #75-94 on September 24, 2008 and submitted the 3<sup>rd</sup> party system impact study performed by Navigant Consulting to the CEC on September 29, 2008. Avenal Power continues to be responsive to CEC staff, and it is Avenal Power's understanding that staff has all the information necessary to finalize the Preliminary Staff Assessment ("PSA").

Additionally, Avenal Power would like to point out that the current siting committee schedule for the Avenal Energy project is no longer accurate as the CEC has not issued the Preliminary Staff Assessment ("PSA") that was scheduled to be issued on October 7, 2008. Avenal Power would like to emphasize to the Commission that this Project has continued to provide responses within the scheduled timeline but is concerned with the significant slippage in the siting committee schedule for the Project. Avenal Power is aware of the current workload at the Commission but is concerned about the continued delays to the PSA. Avenal Power requests that the Committee check into the status of the PSA and the overall schedule for this project with the intent of getting the PSA out for public review. Avenal Power continues to support CEC

staff's review of this Project and looks forward to scheduling a PSA workshop within the next month.
