On September 10, 2008, Northern California Power Agency (NCPA) submitted an Application for Certification (AFC) to the California Energy Commission to construct and operate an electrical generating plant in the City of Lodi, San Joaquin County, California. The Lodi Energy Center (LEC) would be a combined-cycle, nominal 255-megawatt (MW) power generation facility. The proposed project would be located on 4.4 acres of land owned and incorporated by the City of Lodi, 6 miles west of the Lodi city center, located near Interstate-5 (I-5) approximately 1.7 miles south of State Route 12.

On November 20, 2008, the California Energy Commission determined the AFC to be complete, and staff is now in the discovery and analysis phases of the approximately 12-month project review process.

On March 19, 2009, the Energy Commission received Supplement C- Natural Gas Supply Line Route Change for the Lodi Energy Center AFC. This change is the result of NCPA conferring with the Pacific Gas and Electric Company (PG&E), regarding the existing easements for the 8-inch natural gas supply line for the NCPA's Combustion Turbine Project #2 and discovering that the natural gas supply line was actually located along a route different than the one shown in the AFC.
