Pursuant to sections 1207 and 1712 of Title 20 of the California Code of Regulations, PETITIONER Coalition for Fair Employment in Construction states:

1. Petitioner is an organization known as Coalition for Fair Employment in Construction (hereinafter "CFEC").
2. CFEC petitions to intervene in the above-captioned proceeding. Petitioner CFEC is a non-profit association organized under laws of the State of California. CFEC is comprised of over 300 California contractors who, in turn, employ over 40,000 workers. Members of CFEC are taxpayers and citizens of Sacramento County and surrounding areas.
