## Beacon Solar Energy Project (08-AFC-2) Preliminary Staff Assessment (PSA)

Thank you for giving the California Department of Transportation (Caltrans) District 9 the opportunity to review the PSA for the Solar Energy Project located in Kern County northeast of State Route 14 (SR-14). We appreciate previous interaction with you and project proponents.

We have the following comments:

- Figure 1- Regional Vicinity Map: see enclosure for depiction of State Highways.
- Reference to SR-58 should be to SR-14 on page 4.4-13.
- Regarding Hydrology, the document addresses concerns previously discussed with Andrew Brandt of Caltrans. Although affect upon the State Highway System should be little to none, please continue to provide us any follow-up reports pertaining to drainage.
- In the Critical Highway and Roads section (page 4.10-3), SR-14 is a north-south route comprised of both freeway and expressway segments. Also change "SR-85" to "SR-58."
- In the Traffic & Transportation Table 3, Project Compliance with Adopted Traffic and Transportation LORS, <u>Local:</u> (page 4.10-14): for clarification, replace "below the LOS D threshold" with "better than the LOS D threshold."
- For Proposed Condition of Certification, TRANS-1 (page 4.10-15) please add verbiage –

   into the project site "by obtaining an encroachment permit from Caltrans, District 9 in Bishop."
- An important of Static interaction of Static according to a field.
- If any work regarding the project security fence is to be within State right-of-way, a Caltrans permit would be required. If the security fence is to also function as the right-of-way fence, it shall meet Caltrans standards. To address this, another Condition of Certification may be needed or perhaps include it with item HAZ-5 (page 4.4-15).

• A Caltrans permit is also required for placing the transmission line across SR-14. Please include this as another Condition of Certification for TRANS or elsewhere.
