Commissioners Bryon and Pfannenstiel;

On November 14, 2008 Staff issued Data Requests 1-52 in proceeding 08-AFC-5. Section 1716 (f) of the Commission's regulations require Applicant to inform the Committee within 20 days if there are objections to certain data requests, or if responses to certain data requests cannot be filed within the 30 day response deadline. Applicant does not object to any data requests. However, data requests 37 and 38 will take longer than 30 days to develop an adequate response. These two data requests seek information on the reliability of the proposed water supply. Applicant seeks 60 additional days to respond to these two data requests.
