**REQUEST FOR AGENCY PARTICIPATION IN THE REVIEW OF THE GWF TRACY
COMBINED CYCLE POWER PLANT APPLICATION FOR CERTIFICATION
(08-AFC-7) – SUPPLEMENTAL INFORMATION**

On July 18, 2008, the California Energy Commission received an Application for Certification (AFC) from GWF Energy, LLC for the GWF Tracy Combined Cycle Power Plant Project (GWF Tracy). GWF Energy, LLC proposes to modify the existing Tracy Peaker Plant (TPP) (01-AFC-16), a nominal 169-megawatt (MW) simple-cycle power plant by converting the facility into a combined cycle power plant with a new nominal capacity of 314 MW. The proposed project would occupy a 16.38-acre, fenced site within the existing GWF-owned 40-acre parcel in an unincorporated portion of San Joaquin County immediately southwest of Tracy, California.

On September 5, 2008, the California Energy Commission received a supplement to the GWF Tracy AFC. This supplemental information provides additional information and clarifications of and more detailed explanations about the information contained in the original AFC. On September 10, 2008, the Energy Commission found that, with the supplement, the application is complete. The staff of the Energy Commission has now begun the data discovery and analysis phases of the project's 12-month licensing process. Your agency's preliminary and final determinations regarding the project's compliance with requirements administered by your agency are due by **January 10, 2009** and **March 10, 2009**, respectively.
