

Re: Application for Certification Tracy Peaker Plant – GWF Energy LLC



Dear Ms. Jones:

GWF Energy LLC is pleased to submit its Application for Certification for the GWF Tracy Combined Cycle Power Plant, a nominal 314 megawatt (MW) combined cycle natural gas-fired power plant to be located southwest of the City of Tracy, in western San Joaquin County. The project will include the modification of GWF's Tracy Peaker Plant (01-AFC-16) adding two heat recovery steam generator units, a 145 MW steam turbine and an air cooled condenser unit along with supporting changes to existing interconnect transmission systems of PG&E. There would be no changes necessary to the existing natural gas interconnection or water supply system for the project.

The conversion of the Tracy Peaker Plant to a GWF Tracy combined cycle plant is prudent in addressing the future electricity needs of California. Tracy Peaker Plant will continue to supply power to the California Department of Water Resources (DWR) until 2012 under a 10-year contract, executed by both parties on May 11, 2003.

The GWF Tracy has been designed to be constructed and operated in compliance with all applicable laws, regulations and standards (LORS). All potentially significant environmental impacts will be mitigated, and the project will not have an adverse impact on the electrical system.

GWF Energy LLC therefore requests that the GWF Tracy Combined Cycle project be processed under licensing process envisioned under Title 20 of the California Code of Regulations, sections 1701 et seq.

GWF Energy LLC looks forward to working with the Commission staff, our neighbors, and the community on the project.
