On behalf of the City of Palmdale ("City"), the applicant for the above-referenced Palmdale Hybrid Power Project ("PHPP"), and in response to a request from the California Department of Fish and Game, I am providing a revised map depicting potential compensation mitigation lands along with the locations of actual Mohave ground squirrel sitings since 1990 ("Mitigation Map"). The Mitigation Map is confidential because it includes information regarding the location of potential biological mitigation areas. The Mitigation Map is related to previously submitted materials associated with Applicant's supplemental responses to Data Request CC-BI, which along with other responses to the requests raised at the Committee Conference, was mailed on July 22, 2009.

The City requests that the enclosed Mitigation Map be designated confidential pursuant to 20 Cal. Code Regs. section 2505 (regarding the designation of confidential records). The City requests that the entirety of the enclosed Mitigation Map be kept confidential indefinitely in order to ensure protection of potentially sensitive resources and for financial reasons, as disclosure of the desirability of these areas could affect land acquisition prices. The City requests that the Mitigation Map not be disclosed even if aggregated with other information or redacted to conceal certain information.

The City has not disclosed any of the subject confidential information to anyone other than its employees, attorneys, and consultants working on the AFC for the PHPP. Moreover, this information has not been disclosed to persons employed by or working for the City except on a
