COMMENTS:

Here is a summary of my conversation with Ray:

- In 2010, the Lancaster Wastewater Reclamation Plant (LWRP) tertiary upgrade is scheduled to be complete.
- In mid-2011, the Palmdale Wastewater Reclamation Plant tertiary upgrade is scheduled to be complete. SWRCB SRF (State Revolving Fund) money may be necessary for completion of the PWRP. However, the District went ahead using their own money and started construction of the tertiary upgrade because of the RWQCB Cease & Desist orders.
- First leg of the interconnection pipeline is complete. Ray thinks it is another two years before the full pipeline would be complete, but I should call Waterworks for an accurate completion schedule.
- Ray said connection to the City of Rosamond WWTP is an idea that might happen in the future.
- When the PWRP and LWRP are connected, there will be a total of 25,000 AFY recycled water available. Waterworks bought 13,500 AFY of that water through a contract with the Sanitation District.
- Ray emailed to me a copy of the contract between the L.A. Sanitation District and the L.A. County Waterworks #40 for the supply of recycled water (13,500 AFY).
- The agreement is a 3-way agreement – PWRP-LWRP-Waterworks. So, there is enough water for a backup supply.
- Waterworks would in turn sell the recycled water to other water purveyors and businesses.
- Waterworks is responsible for building the pumphouses and delivery lines for the recycled water.
- Waterworks already prepared the facility plans and EIR for the project.
