 STATUS REPORT #4**

Pursuant to the Committee Scheduling Order dated December 14, 2009, the following is staff's Status Report #4 for the proposed Watson Cogeneration Steam and Electric Reliability (BP Watson) Project.

**Preliminary Staff Assessment**

Staff has been working through the analysis phase of the Application for Certification (AFC) process for the proposed BP Watson project. With the exception of Air Quality, staff is finalizing the PSA. The Air Quality technical review is incomplete pending receipt of the Preliminary Determination of Compliance (PDOC) from the South Coast Air Quality Management District (SCAQMD).

**South Coast Air Quality Management District**

The Air Quality section of the PSA cannot be completed until the PDOC is issued. The Energy Commission's air quality staff will complete work on their PSA section after the PDOC is issued.

Following the completion and review of the Air Quality section, staff will publish the PSA.

**Schedule**

The PSA was scheduled to be filed on April 15, 2010, with a PSA Workshop scheduled to be held on April 26, 2010. Due to the delays, these dates are being postponed. A more specific timeline will be proposed after the PDOC is issued.

Staff will publish another status report on May 28, 2010 to update any information regarding the PDOC and PSA.
