Dear Mr. Caswell:

In response to inquires made by the California Energy Commission (CEC) on March 2, 2009, please find below Diamond Generating Corporation's (DGC's) response regarding the compliance status of the Indigo Energy Facility (Indigo) and Larkspur Energy Facility (Larkspur). Both facilities currently hold Title V Permits; Indigo under the jurisdiction of the South Coast Air Quality Management District (SCAQMD, Facility ID #127299), and Larkspur under the jurisdiction of the San Diego Air Pollution Control District (SDAPCD, Permit #978248). Per a conference call between the CEC, DGC, and DGC's consultant (ENVIRON International Corporation) on March 2, 2009, the CEC has requested the number of yearly startups and shutdowns for each turbine at Indigo and Larkspur. Tables summarizing this information are presented below. As shown, the turbines presently undergo less than 365 startup/shutdowns per year as referenced in the CEC License Application, Attachment B; however, the facilities have the ability and may be required by California System Operator (Caiso) by its tariff to startup and shutdown more than 365 times per year depending on electricity demand. Neither SCAQMD nor SDAPCD permit restricts the number of startup and shutdowns the turbines can have.
