On September 8, 2010, the Commission issued a Notice of Prehearing Conference and Evidentiary Hearing. In response to this Notice, this Prehearing Conference Statement contains the following information:

1. ***The topic areas that are complete and ready to proceed to evidentiary hearing.***

All topics are complete and ready to proceed.

2. ***The topic areas that are not complete and not yet ready to proceed to evidentiary hearing, and the reasons therefor.***

All topics are complete and ready to proceed.

3. ***The topic areas that remain disputed and require adjudication, and the precise nature of the dispute for each topic.***

No topic area requires adjudication.

4. ***The identity of each witness sponsored by each party (note: witnesses must have professional expertise in the scope of their testimony); the topic area(s) which each witness will present; a brief summary of the testimony to be offered by each witness; qualifications of each witness; and the time required to present direct testimony by each witness.***

The Applicant's witnesses, their topic areas, a brief summary of their testimony, and their qualifications are set forth in the Applicant's pre-filed testimony filed on September 20, 2010. A list of the Applicant's witnesses and their topic areas is attached hereto as Attachment 1. As for direct examination, the Applicant does not anticipate a need for direct examination of any witnesses.

5. ***Topic areas upon which a party desires to cross-examine witnesses, a summary of the scope of such cross-examination, and the time desired for such cross-examination.***

The Applicant does not anticipate cross-examination of CEC Staff on any topic areas.

6. ***An exhibit list identifying exhibits and declarations that each party intends to offer into evidence (see attached sample for required format). The Hearing Officer will provide the parties with a Word version of the Exhibit List template.***

The Applicant's exhibit list is attached hereto as Attachment 2. Also attached is the Applicant's exhibit list by topic (Attachment 3). The Declarations are attached to Applicant's pre-filed testimony, submitted September 20, 2010.

7. *Proposals for briefing deadlines, vacation schedules, and other scheduling matters.*

On September 1, 2009, the Committee issued an order setting forth the Schedule for this case. The Applicant does not expect there will be a need for briefing. However, the Applicant can commit to submitting an opening brief ten days from when the transcripts for the Prehearing Conference and Evidentiary Hearings are available, or Thursday October 21st, 2010, whichever is later. Applicant can commit to submitting a reply brief ten days after the opening briefs are due. The Schedule with Applicant's proposed briefing deadlines and other post-hearing events is attached hereto as Attachment 4. In addition, the Applicant respectfully requests that the Committee request an expedited transcript of the Evidentiary Hearings.


