Dear Ms. Squires:

I am writing to initiate consultation under section 7 of the Endangered Species Act for a Department of the Army Permit application for the Mariposa Energy Project. The project is located near the California Aqueduct, in Section 1, Township 2 South, Range 3 East, Latitude 37.79023°, Longitude -121.60233°, MDB&M, Alameda County, California. A copy of the applicant's April 2010, *Mariposa Energy Project Biological Assessment* was mailed to you on April 16, 2010.

Based on the available information, we have determined the action may affect the Federally-listed California red-legged frog (*Rana aurora draytonii*), San Joaquin kit fox (*Vulpes macrotis mutica*), California tiger salamander (*Ambystoma californiense*), vernal pool fairy shrimp (*Branchinecta lynchi*), longhorn fairy shrimp (*Branchinecta longiantenna*) and/or their critical habitat. If new information becomes available indicating that other listed species or critical habitat may be affected, we will follow the procedures under 50 CFR 402.16, reinitiation of consultation.

Formal consultation as defined in 50 CFR 402.02 commences with your receipt of this letter. The following information is included to initiate consultation:

1. A description of the action to be considered: Mariposa Energy proposes to construct and operate the Mariposa Energy Project (MEP) electrical generating facility, which includes a 10.3-acre facility site and road, a 9.2-acre temporary parking and work area, a 580' by 75' gas pipeline work corridor, a 0.7-mile by 100' transmission line work corridor, and a 1.8-mile by 15' water supply pipeline work corridor.

2. A description of the specific area that may be affected by the action: The MEP is proposed to be located in northeastern Alameda County, southeast of the intersection of Kelso and Bruns Roads. The majority of the site is non-irrigated pasture. See Figures 1 and 2.

3. A description of any listed species or critical habitat that may be affected by the action: California red-legged frog (*Rana aurora draytonii*), San Joaquin kit fox (*Vulpes macrotis mutica*), California tiger salamander (*Ambystoma californiense*), vernal pool fairy shrimp (*Branchinecta lynchi*), longhorn fairy shrimp (*Branchinecta longiantenna*) and/or their critical habitat.

4. A description of the manner in which the action may affect any listed species or critical habitat and analysis of any cumulative impacts: There is a potential for take of listed fairy shrimp, frog and salamander during construction and operation due to sediment or other material being released via stormwater into nearby wetlands; potential for take of frog, salamander and kit fox during construction and operation, caused by

vehicles and other equipment. Cumulative impacts may occur as a result of new developments and operation and maintenance of existing facilities in the action area.

5. Relevant reports including any environmental impact statement, environmental assessment, or biological assessment prepared: See Biological Assessment, Section 7 References.

6. Any other relevant available information on the action, the listed species, or critical habitat: See Biological Assessment, Section 7 References.

This constitutes the best scientific and commercial data available. If you need additional information, or determine conditioning the permit or modifying the project would preclude the need for formal consultation, please contact us immediately. You may also contact the applicant or authorized agent to allow them the opportunity to provide information for consideration as prescribed by 50 CFR 402.14(d). If you need additional data beyond that discussed above, the procedures of 50 CFR 402.14(f) must be followed.
