Pursuant to the Committee Scheduling Order dated October 30, 2009, the following is staff's Status Report #5 for the proposed Mariposa Energy Project (MEP). This is an update for activities that have occurred since the previous Status Report on March 30, 2010.

Outstanding Data Responses

The applicant is working on responses to comments from the Contra Costa County Airport Land Use Commission; Keith Freitas - Contra Costa County Director of Airports and Hal Yeager - Contra Costa County Airport Land Use Commissioner.

Staff needs these data responses prior to completion of the Preliminary Staff Assessment (PSA).

Bay Area Air Quality Management District

The applicant is currently working with the Bay Area Air Quality Management District (BAAQMD) in regard to appropriate current air district standards and the information to prepare the Preliminary Determination of Compliance (PDOC). The delay of the PDOC is creating a delay in the preparation of the Air Quality analysis.

Project Schedule

The project schedule is dependent upon the applicant providing complete data responses and the PDOC being issued by the air district. Staff is unable to commit to a schedule at this time without assurances on when the PDOC will be issued. Once staff knows when the PDOC will be issued, we will propose a modified schedule.

Staff will continue to keep the Committee apprised of current work products and critical timelines, and a project status report will be prepared for June 1, 2010.
