

NOTICE OF RECEIPT PETITION TO MODIFY

THE GENERAL ARRANGEMENT OF THE PROJECT SITE FOR THE CPV SENTINEL ENERGY PROJECT

(07-AFC-3C)

A petition was filed on June 6, 2011 with the California Energy Commission by CPV Sentinel, LLC, requesting to modify the CPV Sentinel Energy Project. The 850-megawatt project was certified by the Energy Commission on December 10, 2010, and began construction on June 1, 2011. The facility will be located near Desert Hot Springs, in Riverside County.

DESCRIPTION OF PROPOSED MODIFICATIONS

The modifications proposed in the petition would change the general arrangement of project components. A number of structures are changing location within the 37 acres of the original site. In some cases, project components are changing in size. A new 49-foot-tall wastewater collection tank is proposed to replace the two 40-foottall ZLD evaporator towers within the wastewater treatment area.

On July 11, 2011, a comment was received concerning the proposed changes to the CPV Sentinel Energy Project site. This Petition to Modify is now being processed as an amendment pursuant to Title 20, Calif. Code of Regulations, section 1769.

ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality, public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and, if the project, as modified, will remain in compliance with applicable laws, ordinances, regulations, and standards (Title 20, Calif. Code of Regulations, section 1769). Energy Commission staff is currently analyzing the request and will publish an analysis in the near future. A public hearing for the purpose of approving or denying the amendment proposal will be held at a regularly scheduled Energy Commission business meeting.

This Notice of Receipt is being mailed to interested parties and property owners adjacent to the project site who may want to participate in the amendment process.
