**Re: Calico Solar Project Amendment (CSPA) (08-AFC-13C)
Patrick C. Jackson Data Request Set 1 (Nos. 1-13)**

Dear Messrs. Hoffman and Jackson:

This letter is in response to Patrick C. Jackson Data Request Set 1 (Nos. 1-13) dated May 16, 2011. Pursuant to Section 1716(f) of the Energy Commission's Regulations, Calico Solar informs you that it will be unable to provide certain information requested within 30 days of the date the request was made and that it objects to providing certain information requested, as set forth below.

1. Hydrology, hydraulic and sediment transport/scour studies for the Modified Project AND adjacent private properties affected by the studies. Calico Solar will be unable to provide these studies on June 15, 2011 for the reasons set forth in Calico Solar's May 5, 2011 letter to the Commission regarding Staff's Data Request Set 1 (No. 1-37). The schedule for submitting these studies for the Modified Project was set forth in Calico Solar's Schedule for Additional Submissions docketed May 25, 2011.

These studies will not cover areas outside of the Modified Project site and Calico Solar objects to any data requests calling for such studies. The Modified Project shall not increase erosion of the desert soils or divert storm water from its current path at the site boundaries and post development sediment transport through the project site shall be equal to or less than pre-development runoff as required in the Commission's condition of certification SOIL&WATER-8. Post-construction storm water flows emanating from the project site must not exceed predevelopment levels as indicated in the Supplement Staff Assessment (SSA), July 2010, Soil and Water Resources - Appendix C, Requirements for Waste Discharge, at C.7-109.

2. Revised grading and drainage plans for the Modified Project showing the perimeter access roads required by the Approved Project. Calico Solar will be unable to provide revised grading and drainage plans on June 15, 2011 for the reasons set forth in Calico Solar's May 5, 2011 letter. The schedule for submitting these plans for the Modified Project was set forth in Calico Solar's Schedule for Additional Submissions docketed May 25, 2011.

3. Revised grading and drainage plans for the Modified Project AND adjacent private properties affected by the revised grading and drainage plans. Calico Solar will be unable to provide revised grading and drainage plans on June 15, 2011 for the reasons set forth in Calico Solar's May 5, 2011 letter. The schedule for submitting these plans for the Modified Project was set forth in Calico Solar's Schedule for Additional Submissions docketed May 25, 2011.

Calico Solar objects to the request to provide revised grading and drainage plans for areas outside of the Modified Project. As stated in Response to Data Request #1 above, the Modified Project will not affect off-site storm water flow, drainage sediment transport or erosion. Thus, no areas outside of the Modified Project will be affected by the revised grading and drainage.

4. Letters of authorization from the adjacent property owners modifying drainage onto or off their properties. Calico Solar objects to this data request. As stated in Response to Data Requests #1 and 3 above, the Modified Project will not modify drainage onto or off adjacent properties and thus Calico Solar will not seek any letters of authorizations for drainage modification.

5. Revised Drainage, Erosion and Sediment Control Plan (DESCP) for the Modified Project AND adjacent private properties affected by the revised DESCP. Calico Solar will be unable to provide the revised DESCP on June 15, 2011 for the reasons set forth in Calico Solar's May 5, 2011 letter. The schedule for submitting the revised DESCP for the Modified Project was set forth in Calico Solar's Schedule for Additional Submissions docketed May 25, 2011.

Calico Solar objects to the request to provide a revised DESCP for the areas outside of the Modified Project. As stated in Response to Data Request #1 and 3 above, the Modified Project will not affect off-site storm water flow, drainage, sediment transport or erosion. Thus, no areas outside of the Modified Project will be affected by the revised DESCP.

6. Identify the "Public Access Routes" Calico Solar proposes to use to access the portion of the Project north of the BNSF railroad tracks in the event that Calico Solar is unable to obtain BNSF's approval for a railroad crossing. As set forth in its Petition to Amend, Calico Solar does not propose to access the northern portion of the Modified Project, except by crossing the BNSF railroad. Calico Solar has a complaint pending before the California Public Utilities Commission (PUC) requesting that the PUC order BNSF to give Calico Solar temporary and permanent crossings. Calico Solar expects a favorable decision from the PUC this year. Pending a decision from the PUC or settlement with BNSF, Calico Solar and its consultants have on occasion accessed the northern portion of the site using BLM open routes (AF 121, AF 122, AF 42, AF 133, AF 052) from Newberry Springs.

7. Necessary environmental impact studies to show the "Public Access Routes" comply with CEQA. Calico Solar objects to this data request. As stated in Response to Data Request #6, Calico Solar does not propose to use "Public Access Routes" to access the northern portion of the Modified Project. Additionally, the minimal use of public access routes prior to obtaining a right to cross the BNSF railroad does not require any discretionary approval. Therefore, no CEQA studies are needed.

8. Soil studies showing the level and distribution of *Coccidioides* in the Project area. Calico Solar will be unable to provide these studies on June 15, 2011. Calico has identified Tetra Tech as the consultant to complete these studies. Calico expects these studies to be completed by August 1, 2011.

10. A summary of all employees, contractors and sub-contractors who have visited the Project and have Valley Fever symptoms. Calico Solar has been in ongoing communication with employees, contractors and sub-contractors who have performed work on the site and is unaware of any who have contracted Valley Fever. Calico Solar notes that the version of WORKER SAFETY-7, which was included in the SA/DEIS and referenced in this data request, was not adopted by the Commission in its December 1, 2010 Decision certifying the Approved Project.

11. Detailed analysis of the impact soil disturbance will have dispersing *Coccidioides*. Calico Solar will be unable to provide this analysis on June 15, 2011. Calico Solar has identified Tetra Tech as the consultant to complete this analysis and is working on sampling protocol. Calico expects this analysis to be completed by August 1, 2011.

In his Data Request Set 1, Mr. Jackson states that in September 2010, he became very ill and in January 2011 he was diagnosed as having contracted Valley Fever. Mr. Jackson also states that he has reason to believe that he contracted Valley Fever when he visited his property located near the Project during Calico Solar's soil disturbing activities and geotechnical excavations. If Mr. Jackson would provide Calico Solar with information about his diagnosis, Calico Solar believes that it would be able to conduct a more complete analysis of the impact soil disturbance at the project site may have on dispersing *Coccidioides*. In particular, it would be helpful if Mr. Jackson provided more detailed information on his symptoms, his diagnosis and his course of treatment, as well as the dates on which he believes that he contracted Valley Fever.

12a. Detailed analysis of how WORKER SAFETY-9 will minimize the potential exposure risk to the public (including owners of adjacent properties) from contracting Valley Fever. The language from the SSA quoted by Mr. Jackson states that extensive wetting of the soil prior to and during construction activities should be employed to minimize the public's potential exposure to *coccidioidomycosis*. In connection with its soil sampling and related analysis of the impact of soil disturbance on dispersing *Coccidioides*, Calico Solar will complete further analysis regarding the potential exposure risk to the public of contracting Valley Fever as a result of the proposed project activities. Calico Solar will be unable to provide this analysis on June 15, 2011. Calico Solar has identified Tetra Tech as the consultant to complete this analysis. Calico expects this analysis to be completed by August 1, 2011.

12b. Describe how and when adjacent property owners will be provided dust masks and trained to use the masks. Calico Solar objects to this data request. Calico Solar does not intend to provide dust masks to adjacent property owners. Neither the conditions of certification for the Approved Project nor the conditions of certification for the Modified Project require Calico Solar to provide dust masks to adjacent property owners. WORKER SAFETY-9 requires that *site workers* use dust masks whenever visible dust is present.

12c. Detailed analysis of the impact of wetting of the soil prior to and during construction has on *Coccidioides*. Calico Solar will be unable to provide this analysis on June 15, 2011. Calico expects this analysis to rely in part on the analysis described in Response to Data Request #8, 11 and 12a above. Calico has identified Tetra Tech as the consultant to complete this analysis. Calico Solar expects this analysis to be completed by August 1, 2011.

12d. Detailed analysis of how Project grading and drainage will affect the dispersal of *Coccidioides arthroconidia*. Calico Solar will be unable to provide this analysis on June 15, 2011. Calico expects this analysis to rely in part on the analysis described in Response to Data Request #8, 11, 12a and 12c above. Calico has identified Tetra Tech as the consultant to complete this analysis. Calico Solar expects this analysis to be completed by August 1, 2011.

12e. Detailed analysis of the dispersal of *Coccidioides arthroconidia* when water used for dust control evaporates. Calico Solar will be unable to provide this analysis on June 15, 2011. Calico expects this analysis to rely in part on the analysis described in Response to Data Request #8, 11, 12a, 12c and 12d above. Calico has identified Tetra Tech as the consultant to complete this analysis. Calico Solar expects this analysis to be completed by August 1, 2011.

12f. Detailed analysis describing the impact water from Well#3 will have on the health and safety of workers, owners of adjacent properties and the public. Calico Solar will be unable to provide this analysis on June 15, 2011. Calico expects this analysis to rely in part on the analysis described in Response to Data Request #8, 11, 12a, 12c, 12d and 12e above. Calico has identified Tetra Tech as the consultant to complete this analysis. Calico Solar expects this analysis to be completed by August 1, 2011.

13. A soil study showing the level of arsenic in the Project soils. Calico Solar will be unable to provide this soil study on June 15, 2011. Calico has identified Tetra Tech as the consultant to complete this study. Calico Solar expects this analysis to be completed by August 1, 2011.
