Dear Mr. Lopez:

This is in response to Southern California Edison's (SCE) February 10, 2016, letter requesting extension of the RPS certification application deadline for Salton Sea Power Generation Co #3, Salton Sea Power Generation Co #1, and Salton Sea Power Generation Go #4 facilities. The RPS Eligibility Guidebook, Eighth Edition, adopted in June 2015, established a process to allow the Executive Director to extend and waive application deadlines for RPS certification in certain circumstances and specified the criteria and process for requesting such extensions and waivers.

Energy Commission staff has reviewed the documentation submitted by SCE pursuant to the RPS Eligibility Guidebook, Eighth Edition. Based on the explanation of the circumstances surrounding SCE's inability to submit a timely application for certification and the financial consequences of not granting an extension, I have determined it is appropriate to grant an extension of the RPS certification deadline from September 18, 2008, to May 7, 2012, for the Salton Sea Power Generation Co #3, Salton Sea Power Generation Co #1, and Salton Sea Power Generation Go #4 facilities, and to allow the original RPS eligibility date of March 30, 2005, to be retained.
