Subject: Status Report

K Road Calico Solar Project Amendment (08-AFC-13C)

On June 25, 2012, pursuant to Public Resources Section 25500.1, K Road Calico Solar LLC (K Road) filed a Petition to Amend the K Road Calico Solar Project (Project) to eliminate the SunCatcher solar thermal technology and replace it with photovoltaic technology (PV). The Petition was accepted by the California Energy Commission (CEC) Staff who began to review the Petition, develop its Issue Identification Report, and develop data requests.

Since the time of filing the Petition, K Road has and is currently working on transmission issues related to the CAISO that affect the timing of the Project and could result in possible modifications to the Large Generator Interconnection Agreement (LGIA).

K Road believes that the transmission issues, when resolved, will not modify the current layout of the Project, which we believe further minimizes any environmental impacts of the Project. With the dedication of resources to resolving the transmission issues at this time, K Road has not yet completed supplemental reports (glint and glare and hydrology) for submittal to the CEC Staff on the timeline anticipated when the amendment was filed. CEC Staff has recently issued data requests and requested these supplemental reports.

These studies will not be completed for at least 60 days, pending resolution of the transmission issues. K Road is aware that CEC Staff is currently working on other projects and believes that it would not be productive for CEC Staff or the Committee to conduct a Site Visit and Informational Hearing until after CEC Staff has had an opportunity to review the supplemental reports.

K Road respectfully requests additional time to submit responses to Staff's data requests. K Road also requests that the Committee issue an order requesting Monthly Status Reports beginning October 1 in which the parties provide updates on the responses to data requests. K Road would also request that scheduling a Site Visit and Informational Hearing be timed subsequent to responses to data requests to ensure a more productive use of the CEC Staff's, Committee's and interveners' time.
