PETITION TO TERMINATE APPROVAL TO CONSTRUCT PERMIT
THE ENERGY COMMISSION DECISION for the
IMPERIAL VALLEY SOLAR (08-AFC-5C)

On June 30, 2011, AES Solar Power, LLC. filed a petition with the California Energy Commission (Energy Commission) requesting the Energy Commission license be canceled for the Imperial Valley Solar Project (formerly known as the Stirling Energy Systems Solar Two). Imperial Valley Solar Project was licensed on September 29, 2010, as a nominal 709 megawatts (MW) concentrated solar power facility located approximately 100 miles east of San Diego, 14 miles west of El Centro, and 4 miles east of Ocotillo Wells.

DESCRIPTION OF PETITION

The petition request would cancel the Energy Commission license.

ENERGY COMMISSION REVIEW PROCESS

The purpose of the Energy Commission's review process is to receive any comments relating to the granting of the request. A public hearing for the purpose of approving or denying the petition will be held at a regularly scheduled Energy Commission business meeting.
