

This Repeated Application for Confidential Designation covers additional cultural resources information as titled above.

This additional information is substantially similar and directly related to the cultural resource information supplied to the CEC on September 29, 2009, which was granted confidential designation by the Executive Director. As previously noted this information is being submitted under 20 CCR 2505(a)(4) which states in pertinent part,
