INTRODUCTION

On June 25, 2012, Palen Solar I, LLC filed a Petition to transfer ownership of the Final Decision for the Palen Solar Power Project (PSPP), 09-AFC-7, from Palen Solar I LLC (PSI) to Nalep Solar Project I, LLC¹, a wholly owned, indirect subsidiary of BrightSource Energy, Inc. (BSE). Since the filing of that Petition, BSE has changed the name of the Nelap Solar Project I, LLC to Palen SEGS I, LLC. Palen SEGS I, LLC will continue to be a wholly owned, indirect subsidiary of BrightSource Energy, Inc. (BSE). Please accept this revision to the name of the entity that will ultimately own the PSPP. Attached is a certification from the Secretary of State of Delaware approving the name change.
