



THE CALIFORNIA DEPARTMENT OF WATER RESOURCES REQUESTS APPROVAL OF A THREE YEAR EXTENSION OF SUSPENDED OPERATIONS for the

BOTTLE ROCK GEOTHERMAL POWER PLANT 79-AFC-4C

The California Energy Commission (Commission) has received from the California Department of Water Resources (DWR) a request for a three year extension of Commission Order No. 93-0426-02 (approved April 26, 1993). That order modified and reduced environmental monitoring during a five-year suspension of operations at the Bottle Rock Geothermal Power Plant, a 55 megawatt geothermal power plant located northwest of Cobb, California. The plant was certified in November 1980 and commercial operation began in February 1985.

The Commission's suspension order states that if DWR wishes an extension beyond the five years, they must notify the Commission's Compliance Project Manager six months prior to the end of the suspension period. The end of the five years would be April 26, 1998.

This request for extension is tentatively scheduled to be heard at the December 3, 1997 Commission Business Meeting.
