NOTICE OF RECEIPT

PETITION TO AMEND THE CALIFORNIA ENERGY COMMISSION DECISION for the BOTTLE ROCK GEOTHERMAL POWER PLANT PROJECT (79-AFC-4C)

On March 8, 2013, Bottle Rock Power, LLC, (BRP) filed a petition with the California Energy Commission (Energy Commission) requesting modification of the Bottle Rock Geothermal Power Plant's (Bottle Rock) decommissioning Conditions of Certification (COCs). Originally owned by the California Department of Water Resources (DWR), the 55-megawatt project was certified on November 5, 1980. On April 26, 1993, the Energy Commission granted DWR's petition to suspend Bottle Rock operations due to a lack of steam. In an order dated May 30, 2001, the Energy Commission approved Bottle Rock's ownership transfer from DWR to the Bottle Rock Power Corporation. On December 13, 2006, the Energy Commission approved Bottle Rock's restart of operations and ownership transfer from the Bottle Rock Power Corporation to the BRP. The facility is located in the unincorporated area of Cobb Mountain, in Lake County, California.

DESCRIPTION OF PROPOSED MODIFICATION

This petition proposes deleting language in the Energy Commission's 2001 Order requiring the parties to "strictly adhere" to terms of the Bottle Rock Purchase Agreement, including maintenance of a \$5 million closure bond and a \$10 million environmental impairment insurance policy. Additionally, the modifications would delete existing Biology (5-2), Soils (8-4), and Civil Engineering (9-5) decommissioning requirements and replace them with three updated Compliance COCs for planned and unplanned closures, and one new "Decommissioning Financial Assurances" COC.

ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality and on public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and a determination on whether the project, as modified, will remain in compliance with applicable laws, ordinances, regulations, and standards (Title 20, California Code of Regulations, section 1769). Energy Commission staff is currently analyzing the request and will publish an analysis in the near future. A public hearing for the purpose of approving, denying, or modifying the amendment proposal will be held at a regularly scheduled Energy Commission business meeting.

This Notice of Receipt is being mailed to interested parties and property owners adjacent to the project site who may want to participate in the amendment process.
