On March 4, 2011, the Calpine Corporation filed a petition with the California Energy Commission requesting to change the ownership of the Sutter Energy Center (SEC) project pipeline. The combined cycle 540-megawatt natural gas-fired facility was certified by the Energy Commission on April 14, 1999, and began commercial operation on July 2, 2001. The Sutter Energy Center project is located adjacent to Calpine's Greenleaf Unit #1 cogeneration power plant, approximately seven miles southwest of Yuba City, on South Township Road near the intersection with Best Road.

## **DESCRIPTION OF PROPOSED MODIFICATION**

Calpine Corporation petitions the Energy Commission for a change of ownership approval for its Sutter Energy Center project pipeline. The request is to transfer ownership of the pipeline from Calpine Construction Finance Company, L.P. to CPN Pipeline Company (both are subsidiaries of Calpine Corporation). There will be no operational changes to the project.

Pursuant to Title 20, California Code of Regulations, section 1769(b), CPN Pipeline Company will be responsible for compliance with the Commission's conditions of certification for the Sutter Pipeline. As owner and operator of the Sutter Pipeline, CPN Pipeline Company understands the conditions of certification and agrees to comply with them.

A public hearing for the purpose of approving or denying the petition to change ownership will subsequently be held at a regularly scheduled Energy Commission business meeting. This Notice of Receipt is being mailed to property owners adjacent to the project site and interested parties who may want to participate in the amendment process.
