## NOTICE OF RECEIPT PETITION TO AMEND THE ENERGY COMMISSION DECISION FOR THE **OTAY MESA ENERGY CENTER PROJECT (99-AFC-5C)**

On July 1, 2008, the Otay Mesa Energy Center, LLC filed a complete petition with the California Energy Commission requesting a change to various air quality conditions of certification that were the subject of the project's Amendment 1B, Order 04-0121-08. The 510-megawatt project was certified by the Energy Commission on April 18, 2001. The facility is being constructed in the eastern portion of the Otay Mesa area in San Diego County.

#### DESCRIPTION OF PROPOSED MODIFICATION

The petition proposes to amend air quality conditions of certification that appear in Amendment 1B, Order 04-0121-08, dated January 21, 2004. The proposed changes would affect Conditions of Certification AQ-21; AQ-22; AQ-23; AQ-36; AQ-37; AQ-38; AQ-39; AQ-40; AQ-42; AQ-59; AQ-60; AQ-61 and AQ-83, regarding emission limits. A similar amendment to modify the San Diego Air Pollution Control District's Final Determination Of Compliance conditions is being processed concurrently.

#### **ENERGY COMMISSION REVIEW PROCEDURES**

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality and public health and safety. The review process includes an evaluation of the consistency of the proposed change with the Energy Commission's Decision and if the project, as modified, will remain in compliance with applicable laws, ordinances, regulations, and standards (Title 20, Calif. Code of Regulations, section 1769). Energy Commission staff is currently analyzing the request and plans to publish an analysis in about six weeks. A public hearing for the purpose of approving or denying the amendment proposal will subsequently be held at a regularly scheduled Energy Commission business meeting.

This Notice of Receipt is being mailed to interested parties and property owners adjacent to the project site who may want to participate in the amendment process.
