# **Data Response and Issues Resolution Workshop**

Staff held a Data Response and Issues Resolution Workshop on Friday, April 23rd at the Energy Commission. During this workshop, discussions of the applicant's data responses were held and supplemental information still needed by staff was identified in the areas of air quality, biological resources, transmission system engineering, and water resources.

#### **Outstanding Supplemental Data Responses and Issues**

**Air Quality** – Staff does not currently have all the information that is needed in order to complete its analysis. Staff is working with the applicant to revise the air modeling files to clarify contrasting data. The Bay Area Air Quality Management District has not completed work on the Preliminary Determination of Compliance but has stated to the applicant that they expect to complete this work by the first week of June, 2010.

**Biological Resources** –The applicant is continuing their analysis of the potential impacts of nitrogen deposition from the project to the Antioch Dunes National Wildlife Refuge. The applicant has indicated that an updated report to address staff's data request on this issue should be filed by mid-May, 2010.

**Transmission System Engineering** – Although a Phase I Study was provided to staff, there are some unresolved issues concerning the approximately 100 megawatt (MW) output difference between that study (520 MW) and the output proposed in the AFC (624 MW). The California ISO Phase 2 study is expected to be complete by the end of June 2010, and that study will include the full 634 MW output proposed. Staff cannot conclude the analysis without this information.

**Soils and Water** – Additional information is required for staff to complete its analysis. Staff is working with the applicant to incorporate effects from a potential large flood event into the drainage design and erosion prevention models.

### **Project Schedule**

The Oakley Committee had issued a scheduling order for the project early in the process. Staff is now working towards the following suggested schedule. The unusually heavy workload in the Siting, Transmission and Environmental Protection Division, the Governor's Executive Order S-14-08 regarding renewable energy projects and the impact of furlough days on Energy Commission and other agencies' staff resources have delayed progress. Also, the American Recovery and Reinvestment Act (ARRA) renewable energy projects remain the Division's priority and will require a great deal of staff time in the upcoming months and will continue to impact staff's schedule.
