Contra Costa Generating Station LLC (CCGS LLC), hereby requests the Committee hold a status conference for the Oakley Generating Station (OGS) 09-AFC-4. California Energy Commission (CEC) Staff have been awaiting the Bay Area Air Quality Management District's (BAAQMD) Preliminary Determination of Compliance (PDOC) in order to finalize the Preliminary Staff Assessment (PSA). On October 29th, 2010, the BAAQMD supplied a courtesy copy of the PDOC to CCGS LLC, as well as the CEC Staff. With the release of the PDOC CCGS LLC believes Staff now has all of the information necessary to complete and publish the PSA. The Committee last issued a scheduling order for this case on November 23, 2009. Due to the lengthy delay in obtaining the PDOC for the OGS, CCGS LLC requests the Committee hold a status conference for the purpose of establishing a new schedule for the OGS. We request the PSA be published within the next 30 days.
