**Re: ERRATA - Notice of Rejection of Document entitled "Petition for Reconsideration Robert Sarvey"**

The Docket Unit is informed that certain persons on the Proof of Service List for the Oakley Generating Station (09-AFC-04) received a document entitled "Petition for Reconsideration Robert Sarvey" from Intervenor Robert Sarvey, on Friday June 17, 2011. However, neither the Chief Counsel nor the Docket Unit received this document.

Title 20 of the California Code of Regulations, section 1720 permits a party to petition for reconsideration of a decision or order of the Commission within 30 days after the decision or order is final. The above-referenced document appears to seek reconsideration of the Final Decision of the ~~Mariposa Energy Project~~ Oakley Generating Station filed May 18, 2011. Thirty days from that date is June 17, 2011.

All materials filed with the Commission shall be filed with the Docket Unit (Title 20, Cal.Code.Reg, Section 1209(d).) "A document is filed, received, or similarly submitted when it is delivered in paper or electronic format to the Docket Unit." (Section 1209(e).) The document was not filed by the Docket Unit prior to the thirty-day deadline.

In addition, Section 1720 states that a "petition for reconsideration shall be filed with the Chief Counsel of the Commission." (Section 1720(a).) The document was not filed with the Chief Counsel.

Absent proof of the submittals required by the regulations, Intervenor is informed that the attempt to file a petition for reconsideration is **REJECTED** as untimely and not in conformance with the rules for filing such petitions.
