
On April 5, 2010, the Committee assigned to this proceeding issued a Notice of Mandatory Status Conference and requested that parties file an Issues Statement prior to the status conference outlining a proposed schedule including dates for publication of the Supplemental Staff Assessment, Prehearing Conference, and Evidentiary Hearings and a brief discussion of what obstacles may exist that would hinder completion of this proceeding by September, 2010.

There are issues in Traffic and Transportation, Cultural Resources, and Soil and Water Resources that still need to be resolved and may affect the timing of publication of the Supplemental Staff Assessment. Additionally, staff has not been able to confirm the availability of key staff from participating agencies for evidentiary hearings. Therefore, staff tentatively proposes the following schedule, with the caveat that changes may need to be made:

Supplemental Staff Assessment: June 4, 2010
Applicant and Intervenor Testimony: June 11, 2010
Prehearing Conference: June 18, 2010
Evidentiary Hearings: July 6-7, 2010
