Re: Revised Staff Assessment of the Blythe Solar Power Project (CEC-700-2010-004-REV1)

Dear Mr. Solomon:

EnXco is a global energy developer of wind and solar resources with a Plan of Development (POD) for a solar project located north of the Blythe Solar Power Project (BSPP). We have two concerns about the Revised Staff Assessment (RSA) of the Blythe Solar Power Project: first, we would like to provide an update for the cumulative impacts section of the staff assessment, and second, we are requesting further information on the proposed generation-tie transmission corridor that passes through the middle of the Blythe Solar Power Project.

In the Cumulative Impacts section of the RSA, Table 3 on page B.3-11 refers to ID# M as the NextEra (FPL) McCoy project area, totaling 20,608 acres. In late 2008, however, enXco filed serial application CACA 049490, for over 13,000 acres of the highlighted area with ID# M and, in addition, enXco filed a POD for the enXco McCoy Soleil Project with the Palm Springs BLM office in February, 2009. (shown now in Table 3 as ID# N, but incorrectly mapped on Cumulative Impacts Figure 2). We believe page B.3-11 and Cumulative Impacts Figure 2 should be modified to reflect this change, which takes into greater account progress made by enXco and NextEra in the McCoy area, due to their proximity to the BSPP and implications for transmission interconnection in the I-10 corridor.

Given the location of the enXco and NextEra PODs, due north of the BSPP, it is critically important that the BSPP provide a corridor through the project area for future transmission lines that would serve solar projects developed to the north. Project Description Figure 1 shows the project layout for BSPP, including depiction of a "transmission line corridor" that terminates at the north boundary of the BSPP. The transmission corridor is also illustrated on Traffic and Transportation Figure 1 of the Revised Staff Assessment. Unfortunately, enXco is unable to find any further detail in the RSA, or other public documents from Solar Millennium on the width of the transmission corridor, or its path to the north, where both NextEra and enXco have projects in development. Given the size and number of projects north of the BSPP, a reasonable expectation is that each of three projects could require a double-circuit 230 kV transmission line, so the corridor through the BSPP should be at least 1,000 feet wide.

With the encouragement of the BLM Palm Springs/South Coast Field Office, enXco corresponded with Rachel McMahon, Alice Harron, Michael Cressner, and Elizabeth Ingram of Solar Millennium, in April, 2010 (attachment). In this letter. we requested further information and that we be allowed to coordinate efforts to make sure that project sites to the north of Blythe were not stranded, or forced to pursue transmission line route alternatives in more environmentally or culturally sensitive areas to the east. Unfortunately, we have heard nothing from Solar Millennium and consequently, are writing the CEC to request clarity on the issue.
