Hi Scott -

The development impact fee was not based on the linear facilities, but on administrative and warehouse space related to each power block. We did not have complete information regarding facility location at the time of writing. Therefore, to be conservative, we assumed that the project would pay the full fee. However, my understanding is the same as yours in that the project wouldn't pay a school impact fee on BLM land. As a result, the school impact fee should be \$0 for both Palen and Blythe.

Hi Dennis. For the Blythe Solar Project the AFC indicates that a School Impact Fee would be paid on 246,800 square feet of development (which equals roughly 5.67 acres). The project description indicates that the project would be located on 9,400 acres of BLM land, with BSPP

disturbing 7,030 acres, and BSPP facilities occupying 5,950 acres of land.

My question for you is, what development was used to determine the School Impact Fee? It is my understanding that development within BLM lands would not be required to pay a School Impact Fee. I assumed it was the linear facilities but need clarification from you.

As I am also preparing the Socioeconomics Staff Assessment for the Palen Solar Project, which also indicates a School Impact Fee payment. Please let me know if that was determined in the same manor as Blythe. Thanks,
