PURPOSE

The purpose of the workshop is to allow staff, the applicant, interested agencies, and the public to discuss staff's Revised Staff Assessment which was published on June 4, 2010.

PROJECT DESCRIPTION

On August 24, 2009, the California Energy Commission received an Application For Certification (AFC) from Solar Millennium, LLC and Chevron Energy Solutions to construct and operate the Blythe Solar Power Project in Riverside County.

The Blythe Solar Power Project (project) is a concentrated solar thermal electric generating facility with four adjacent, independent, and identical units of 250 megawatt (MW) nominal capacity each for a total nominal capacity of 1,000 MW. The project is

proposed to be located in the southern California inland desert, approximately eight miles west of the city of Blythe and two miles north of the Interstate-10 freeway in Riverside County, California. The applicants are seeking a right-of-way grant for approximately 9,400 acres of lands owned by the Federal government and administered by the Bureau of Land Management (BLM). Construction and operation of the project would disturb a total of about 7,044 acres.


