**NOTICE OF RECEIPT
PETITION FOR MODIFICATION OF
THE CALIFORNIA ENERGY COMMISSION DECISION FOR THE
ALAMITOS ENERGY CENTER (13-AFC-01C)**

On July 5, 2018, AES Alamitos Energy, LLC (Petitioner), filed a Petition to Amend (PTA) the California Energy Commission (Energy Commission) Final Decision for the Alamitos Energy Center (AEC). The PTA requests additional laydown area for construction materials, equipment, and parking for the AEC project. AEC is located on the site of the Alamitos Generating Station (AGS), an existing and operating power plant located at 690 North Studebaker Road in the city of Long Beach, California.

DESCRIPTION OF PROPOSED MODIFICATION

The PTA (TN 224060) seeks approval to use the additional laydown area for construction activities associated with the Alamitos Energy Center project. The parcel the project seeks to use is owned by Southern California Edison, is covered in gravel, and used for maintenance and construction laydown for the adjacent switchyard.

The petitioner states the requested additional laydown area does not materially change the environmental consequences of the Alamitos Energy Center AFC Final Commission Decision nor change any of the approved conditions of certification.

ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the potential impacts of this proposal on environmental quality and on public health and safety. The review process also includes an evaluation of the consistency of the proposed changes with the Energy Commission's Final Decision and a determination whether the facility, as modified, would remain in compliance with applicable laws, ordinances, regulations, and standards (Cal. Code of Regs., tit, 20, § 1769). After staff has completed its independent review and analysis of this petition, it will publish its assessment for public review and comment. Staff's assessment will provide notice of its intent to either process the proposed changes as a Staff-Approved Project Modification or schedule it for consideration by the Energy Commission at a regularly scheduled Business Meeting.

This Notice of Receipt is being mailed to the Commission's facility mail list of interested parties and property owners adjacent to the facility site. It is also available via the facility listserv. The listserv is an automated Energy Commission system by which information

about this facility is emailed to parties who have subscribed. To subscribe, go to the Commission's webpage for the AEC, cited above, scroll down the right side of the project's webpage to the box labeled "Subscribe," and provide the requested contact information.


